Dear Colleagues,

In its last meeting on December 17, 2023, the Presidency Committee discussed the

financial situation of the IAI, the trend of expenditure and the adequacy of the annual incomes to

meet the needs of the IAJ.

The PC agreed that, as anticipated during the Central Council meeting in Taipei, last

September, it has become necessary to evaluate an increase of the annual contributions, whose

amount has never changed since 2002.

Considering the impact of inflation, the increased activities of the IAJ organs and

the different various activities of the Secretariat, as better explained in the document

enclosed to this email, we have to expect that in the space of 3 years reserves will run out

and the annual incomes will not be sufficient to meet the running costs of the IAI, as

foreseen by the Constitution.

The more effective remedy is to decide an increase in the annual contributions, at least to

compensate the loss of value of the contributions since their last increase, in 2002, what means

an increase of 50% starting from 2025.

Although the proposal for a 50 percent increase may seem surprising, it must be

remembered that for 22 years the automatic fee-adjustment rule established in article 4 of

the Regulations has never been applied. This happened because there were large savings, but

now the savings are not sufficient, in prospective terms, to ensure the survival of the IAJ. The

enclosed document explains how the savings were made and why they are decreasing now.

On behalf of the Presidency Committee, I thank you for the consideration that you and your entire associations will give to this important and urgent matter, keeping in mind the conservation of the role, the credibility and the place we earned through decades of hard work in the world-wide scenario.
